

SCHEDULE B
NON-TRANSFERABLE EXCLUSIVE LIMITED WARRANTY
LOGETRONICS GRAPHIC ARTS PRODUCTS
Effective Date: July, 1990

LogEtronic Corporation (LogE) warrants this product as set forth below, commencing on the date of its first operation at the U.S. premises of the end-user for the time period of 90 days from that date **PROVIDED THAT** said operation commences within 1 year of the date of shipment of said product by **LogE**.

Upon notification, **LogE**, or its authorized dealers, will, in the U.S.A., and during its normal working hours of 8 a.m. to 5 p.m., Monday through Friday, furnish and/or pay for the repair (parts and/or labor), should such service - in the opinion of a **LogE or Authorized LogE Field Service Representative** (FSR) - be required to ensure operation of the product in conformance with the published specifications for the covered product.

For locations outside the continental limits of the U.S.A., the warranty is for the period of 180 days from the date of shipment of the product by **LogE**, during which time replacement parts only will be provided at no cost for any that are found by the installing dealer or end-user, to be defective.

Furthermore, during the first 90 days of operation of said product, at the premises of the end-user, **LogE** will also prepay transportation costs, to the foreign port of entry, for such parts **PROVIDED THAT** said period of operation is completed within 180 days of the date of shipment of said product by **LogE**. Thereafter the dealer or end-user is responsible for payment of all transportation and other costs.

This warrant is **VOID** if the product is modified without written **LogE** authorization, or if it is operated or maintained in a manner contrary to the Specifications or Instruction Manual.

The obligations and liabilities of **LogE** with respect to the sale of its products are limited to the specific undertakings expressly stated in this warranty. **LogE** does not assume responsibility of any purchaser of its products for representations of agent, dealer or person, other than for the undertaking herein express. LogE reserves the right to make changes in design, and changes or improvements upon its products without imposing any obligation upon itself to install the same upon its products heretofore manufactured. In no event or circumstance shall **LogE** be liable for any incidental or consequential damage claims, including claims for loss of materials, time or profit.

***SPECIFIC EXCLUSIONS:** Specifically excluded from the terms of this warranty are all consumable items used within or as a part of **LogE** graphic arts products. Such items include, but are not limited to filters, lamps, glass, vacuum blankets and fuses. **ALSO EXCLUDED** are repair of damages caused by natural disasters such as flood or earthquake, structural failure of the building, failure in any utility system connected to the product and damages caused by "**Acts of God**" such as lightning strikes or other natural phenomenon.*

THIS NON-TRANSFERABLE LIMITED WARRANTY IS EXCLUSIVE, AND IS IN LIEU OF ALL OTHER WARRANTIES EXPRESSED OR STATUTORY, AND WHETHER FOR QUALITY, MERCHANTABILITY, FITNESS OR OTHERWISE.
