Garnett Franklin Scroggins (J53) was a son of William Benjamin Scroggins (H70) and Sciota Rebecca Young who moved from Shelby County, Kentucky, to Louisville, Kentucky. Mary Emaline Martin was a daughter of Gilbert Washington Martin and Sarah Ann "Sallie" Ramsey of Louisville, Kentucky. The parents of Mary Angela "Lan" McIntosh, whose names have not been determined, lived in New Albany, Indiana, in 1944.

Garnett Franklin Scroggins (J53) probably was born at the home of his paternal grandparents in Shelby County, Kentucky, where his parents resided for a while after their marriage. By 1906, when Garnett's brother William Forrest Scroggins (J54) was born, the family lived in Shelbyville, Kentucky. About 1910 or 1911 they lived briefly in Eminence, Kentucky. They moved to Louisville before September 1911 where William, who was five years younger than Garnett, was enrolled in the first grade at Victor H. Englehard School at 1st and York streets. Garnett also attended Englehard School but he soon was in Monserrat School at 5th and York streets which had classes from the 6th through the 8th grades. Garnett next attended Dupont Manual Training High School. During the World War I years 1915-1918, Dupont Manual, which was at Brook and Oak streets, and Louisville Male High School were consolidated as Louisville Boys High School with classes at the Male High facility at Brook and Breckinridge streets. (Recollections of William Forrest Scroggins (J54), Cobbs Creek, Virginia, 1983.)

During WWI young people were encouraged to drop out of high school to enter vital industry. Garnett did so and got a job as a clerk with the Louisville and Nashville Rail Road. There he met Mary Martin, another clerical employee who had left Louisville Girls High School to work at the L&N. On 31 December 1919, when he was 18 and she was 17, they applied for a marriage license in Jeffersonville, Indiana, across the river from Louisville, which for years was a marriage mecca for young Kentuckians because there was no waiting period and proof of age was not required. Garnett represented himself as being born on 08 December 1898, aged 21, and Mary with a birth date of 30 April 1901, aged 18. They were married the same day by F. E. Andrews, a minister: (Clark County, Indiana, Marriage Book 47, page 431.)

Photographs of Mary Martin Scroggins show her to be a pert blonde whose beauty, despite an arduous life as wife and mother, continued into old age. Her sparkling vivacity and devilish personality won for her the eternal love and admiration of Garnett's father and brother. William spoke of her with the highest regard for her beauty, personality and strength of character.

Garnett eventually left the L&N for a career opportunity with the Household Finance Company in Louisville. In 1927 he was sent to Covington, Kentucky, to open and manage a new office. Quickly he was assigned to do the same in Hamilton, Ohio, and before the year was out he was returned to Covington. In 1928 he left HFC to return to Louisville where he joined the Liggett and Myers Tobacco Company as a salesman. Later that year he was assigned to a territory at Shelbyville, Kentucky, and moved there. Part of the responsibility of the tobacco salesmen was to install window displays, using crepe paper designs to decorate the arrangement of products and cardboard display signs. When the tobacco companies decided to handle window displays through outside contractors, Garnett moved to Lexington, Kentucky, in 1929 and established his own business, Bluegrass Display Service, to serve the tobacco industry.

His profession was classified as a department store interior decorator on the 1930 census: [15th Census of the United States, 12 Apr 1930, Lexington, Fayette County, Kentucky Enumeration District 34-17, Supervisors District 35, Sheet 20, Dwelling 436, Family 526, 320 Given Avenue.]

His business was pleasantly successful for a number of years but Garnett lost his contracts due to the deceitful manipulations of a cousin, Sid Hulett, whom he hired as an assistant and trained to create the displays. Sid underbid Garnett for the contracts and left him without a business. Subsequently Garnett was a clerk in a Lexington liquor store and then he became a salesman for a candy company, which entailed regular travel that took him away from home for up to a week at a time. Garnett took his family back to Louisville on New Years Day 1941 to find a job in the burgeoning war industry. He obtained a job as a carpenter on the construction of the Naval Ordnance Depot but his experience was not sufficient for the work. He then became a security guard for the construction site of the Hoosier Ordnance Plant in Indiana, between Jeffersonville and Charlestown. He was the first employee hired locally by the combined contracting group. The chief of security was on temporary duty with the contractors from the Goodyear Engineering Company who would be the operators of the completed plant. Garnett was promoted to assistant chief almost immediately and was changed to the Goodyear payroll when they took over. When the opportunity to be chief of security at a plant in Evansville arose, he left Goodyear.

When Garnett Scroggins went from Louisville, Kentucky, to Evansville, Indiana, in the spring of 1942, he left his first wife Mary Martin Scroggins and children with the understanding that he had a better job in a defense plant there as chief of security and that he would send for his family as soon as he got settled. Before going into the Air Corps in June 1942, his eldest son Bill went to Evansville and visited him briefly. Garnett met Bill at the bus station, drove him around in his car for a while and returned him to the station for his trip home. As Bill recollects, the conversation, as usual with his father, was superficial, awkward and unmemorable.

Communications and money from Garnett to Mary quickly dwindled and she got a job and began supporting herself and her family.

The abandonment was complete. Garnett was not heard from again until his son Ken found his name in an Atlanta telephone book while visiting that city on business for his college fraternity. Although Garnett returned to Kentucky regularly through the years to see his mother, he made no effort to see Mary or his children there.

It was learned that when he went to Evansville, Garnett took Lan McIntosh with him. They met at the Hoosier Ordnance Plant near Jeffersonville, Indiana, where they both were employed. Son Bill worked at the same place, indirectly under the supervision of his dad who was assistant chief of security, but, because of the size of the compound, he usually was unaware of his father's daily activities and oblivious to any special relationship with Lan McIntosh, a beauty who was a focal point of many male eyes. Bill recalls that, on his way to work one morning in a car-pool, he saw his father and Lan approaching the plant together in

his father's car but, as he characterizes it, in his naiveté or stupidity, he gave the incident no special thought at the time. Car-pooling was commonplace and Bill was riding with female friends. Bill and his father did not drive to work together because Garnett's responsibilities required him to appear at the plant at fluctuating times and places.

If Garnett divorced Mary and married Lan before the birth of Nancy in 1943, Mary never was served with notification of the action. The lack of notice to Mary and the chronology suggest that, if Garnett and Lan actually married before the birth of Nancy, the second marriage was bigamous.

The circumstances suggest that Garnett and Lan probably moved from Evansville to Birmingham to Atlanta to evade attempts by Mary to discover his whereabouts.

When this story surfaced, Pat Scroggins, wife of Bill (K39), recalled that, when she began dating Bill, while she was working at Radio Station WGRC in Louisville with Lan's sister, Deal McIntosh, Deal implied that she was familiar with the Scroggins family. This indicates that the McIntosh family knew of the liaison between Lan and Garnett, but Deal never mentioned her sister in Bill's presence and he was unaware of the relationship.

Mary Martin Scroggins terminated her marriage to Garnett by a divorce granted to her on 15 October 1954: (Jefferson County, Kentucky, Certificate 8160.)

On 15 November 1954 in Louisville, Mary Martin Scroggins married James Kenneth Scoggan, Sr., a widower whom she met at Highland Church of Christ. After her death on 01 August 1992 in Lexington, Fayette County, Kentucky, she was buried in the Scoggan family plot (East 1/2, Lot 4, Section 32) in Cave Hill Cemetery in Louisville.

Mary Emaline Martin Scoggan died at age 90 from metastataic carcinoma of the bladder, which she had for two years. According to Phillip Hoffman, M.D., 1221 S. Broadway, Lexington, KY 40503, dementia was a significant condition contributing to her death, but not the cause of the fatal condition. Dementia was his medical description of her loss of short term memory, but she was a placid happy person who recognized her family and demonstrated little confusion over the identity of visitors. She resided in an apartment with assisted living, and went to the dining room for her meals up until the last weeks of her life, when she lost interest in food. Because of her age, she, with the concurrence of her children, elected not to have chemo-therapy for her cancer and, with the grace of God, did not suffer any pain with the condition, which did cause incontinence. Her death certificate states that she was a white female born on 30 April 1902 in Louisville Kentucky. A widowed homemaker, her parents were Gilbert Washington Martin and Sarah Ann Ramsey. Her Social Security number was 403-90-3420. She resided at 3310 Tates Creek Road, #320, Lexington (Fayette County), KY 40502, where she died. The informant was Mrs. Jeanne Guffy, 1600 Morgantown Road, Pinehurst, NC 28374. The undertaker was Highlands Funeral Home, 3331 Taylorsville Road, Louisville, KY 40205. [Commonwealth of Kentucky, Certificate of Death 19771.]

The Scroggins were Baptists and the Young family belonged to the Christian Church but Garnett's mother became a Baptist when she married. For a while in Louisville, his mother was persuaded by a friend and neighbor to the practice of Christian Science. A woman of frail health, she was happy and well in this discipline but after the friend died, she resumed her attendance at the Baptist church. After his marriage Garnett joined the Parkland Church of Christ, his wife's denomination. In Louisville Garnett and Mary would attend services in Parkland on Sunday mornings and on Sunday evenings they would go to Walnut Street Baptist Church where his father sang in the choir. In Lexington the family attended Cramer and Hanover Church of Christ. Once back in Louisville they joined Highland Church of Christ.

Photographs, taken from boyhood to middle age, show Garnett to be extraordinarily handsome. Women found him very attractive. He was a quiet man, described by some as a loner who could not express his emotions easily. Those who knew him best considered him to be a gentle, sweet and loving man. He was a caring, considerate father, even-tempered and

loathe to punish. His family appeared to be his top priority and he was seldom away from home and family overnight until he became a traveling salesman. Considering the loneliness of the road and his appeal to women, his marital infidelity probably began at this time.

Upon their return to Louisville, Garnett and his family stayed briefly with his brother William in the Highlands, while Garnett sought employment. After being hired as guards for the ordnance plant, Garnett was assigned to the construction site in Indiana and his son Bill was placed at the reception desk in the employment office in downtown Louisville. While looking for a furnished house to rent, suitable to a large family, Garnett and Bill shared a rented room in central Louisville, near the office where Bill worked, and Mary and the younger children went to visit old friends from Shelbyville, Homer and Gladys Yates Kearns, who had moved to the Crescent Hill area of Louisville.

During the brief time that they roomed together, Garnett made no effort to develop a closer relationship with his oldest son. They seldom even ate together. This was because of differing work schedules and places but, in retrospect, it appears hat Garnett already was forging a life away from his family. Bill recalls no meaningful or memorable conversation with his father at any time but they surely must have spoken together at length about some subject at some time.

When, at the age of 12, his son Bill wanted a paper route to earn money for a bicycle, the only one available was a suburban delivery in the morning. Garnett got up early every day, took Bill to the newspaper office, helped him fold the papers and then drove him around the neighborhood to deliver them. In these early morning hours he taught Bill to drive the car. During this same time Bill joined a Boy Scout troop that was being formed at a neighborhood church and Garnett volunteered as Scoutmaster to help organize the group. Bill recollects them being at meetings together, his father telling ghost stories to the boys and helping him learn to tie knots. Although specific instances of momentous guidance and counseling or philosophic instruction do not come to mind, Bill is convinced that his father quietly laid a sound base for living beneath his children.

The early memories of Garnett's children recall only happy times with their father; making ice cream, playing games and going for rides in the country. When Bill was young, Garnett put together a large electric train layout mounted on a wooden base, containing hills, tunnels, bridges and buildings. He had an artistic imagination, evidenced in a number of ways such as his talent for creating crepe paper flowers and designs for window displays which was popular in the 1920's and 30's. He was deft with his hands and had beautiful penmanship. He liked woodworking and made several pieces of furniture. He also made a small picket fence with lights on each post which traditionally encircled the family Christmas tree. These things and the other furnishings of the family were lost. When they moved back to Louisville, everything was placed in temporary storage in Lexington but by the time that they were getting settled in Louisville, Garnett left and their property was never recovered.

Garnett found pleasure in fishing and during their first years in Lexington the family enjoyed summer holidays in a cabin at Lake Herrington and camping at Valley View on the Kentucky River. He and Mary enjoyed playing cards and had regular bridge games with friends.

Garnett obtained gratification from having nice automobiles, keeping them sparkling clean and shiny. Car washing was a family event. Family drives around central Kentucky were traditional. They made occasional outings to the beach at Boonesborough and to places such as Natural Bridge. The family frequently visited relatives in Shelby County, near Bagdad, and the village of Hatton in Franklin County.

Garnett dressed neatly; white shirts, quiet ties and mostly dark suits of moderate quality. His shoes were always polished impeccably.

After the reasonable success of his first adult years, Garnett's life became more of an economic struggle when he lost his business about 1934 in the midst of the depression. At this crossroads in his life, Garnett opened his home to Mary's aged parents and to her niece, Eunice Marie Gunn. Another child also came along to add to the strain of the financial burden.

Garnett's life may be a classic tragedy of a country boy who moved to the city and had the talent and ability to grow in the new environment. Just when his growth was at its most vigorous, it was strangled by circumstances that resulted in a gloomy struggle to survive. Later at mid-life, when conditions began to ease for him, the temptation of a new beginning, with a beautiful younger woman and without the burdensome responsibility of a dependent family, lured him down a happy street from which there was no return. It had been said that his last years were tortured with ambivalence, unable to bridge the gap between the two worlds that he created.

A cigarette smoker, Garnett Franklin Scroggins, Sr. (J53) died of a coronary occlusion in Atlanta, Fulton County, Georgia, on 04 June 1956, the tenth birthday of his first grandchild, none of whom he ever saw. At this time he was a supervisor for a storage company and resided at 2287 Brown's Mill Road S.E., in Atlanta. When his heart attack occurred he was taken to Spring and Peachtree Hospital where he died. Apparently because Lan McIntosh was raised as a Roman Catholic, she selected a Catholic priest to officiate at his funeral at the H. M. Patterson and Son Mortuary on Spring Street in Atlanta. He was buried in West View Cemetery on 06 June 1956. His sons Bill and Shag attended the services and met Lan and their half-sister Nancy whom they visited at their home. Garnett was described as a white male, aged 54, born on 08 December 1901 in Kentucky and a citizen of the USA. His spouse was Mary McIntosh and his parents were given as William F. (sic) Scroggins and Otia Young by the informant, Mrs. G. F. Scroggins of Atlanta. (Georgia Department of Public Health Certificate of Death File No. 13859.)

William Gilbert Scroggins (K39), who was named for his grandfathers, was born at 728AM on 13 July 1921 at home, 1362 Hemlock Street, Louisville, Jefferson County, Kentucky. The attending physician was Dr. Emmet F. Horine, 1036 Bardstown Road, Louisville, Kentucky. A male, he was identified as the first child of the mother whose maiden name was Mary Emmaline (sic) Martin. She was white, 19, and a housewife born in Louisville, Kentucky. The father Garnett Franklin Scroggins was white, 19, and a clerk for the Louisville and Nashville Rail Road Company who was born in Shelby County, Kentucky. (Kentucky Birth Certificate 46918, Volume 94.)

Mary Garnett Scroggins (K40), who was named for her parents, also was delivered at home, 1362 Hemlock Street, Louisville, Jefferson County, Kentucky, at 1240PM on 15 February 1923 by Dr. Horine, whose office now was 370 Francis Building, Louisville. A female, she was the second child of Mary Emmaline (sic) Martin who was white, 21 (not until April), and a housewife born in Louisville, Kentucky. The father Garnett Franklin Scroggins was white, 21, and a clerk for the L. & N. R. R. who was a native of Shelby County, Kentucky. (Kentucky Birth Certificate 20220, Volume 41.)

Mary Garnett died at age 2 months and 10 days from cardio atelestasis according to the diagnosis by coroner Ray L. Carter. This means that her heart was imperfectly developed. She was found dead and had not been in the care of a physician. She was not being treated by a doctor because her parents were unaware of any abnormality in their baby daughter. She had shown no signs of illness but just failed to waken from a nap. The time of her death was set at 800PM on 22 April 1923 at 1362 Hemlock Street, Louisville, Kentucky. She was buried in Cave Hill Cemetery by Schoppenhorst Brothers Mortuary of Louisville on 24 April 1923. The informant, Garnett Scroggins of 1362 Hemlock Street, described her as a white female born on 12 February 1923 at Louisville, Kentucky. Her parents Garnett Scroggins and Mary E. Martin both were natives of Kentucky. (Kentucky Death Certificate 11019, Volume 23.)

Garnett and Mary Scroggins had moved to 112 West Oak Street, Louisville, Jefferson County, Kentucky, by the time that their third child Shirley Martin Scroggins (K41) was born there at 908AM on 14 September 1924. They also had changed doctors. The attending physician was Walter I. Hume whose office was 814 Francis Building, Louisville. A male, Shirley was incorrectly identified as the second child of Mary Emeline (sic) Martin and the second living child. The father Garnett Franklin Scroggins was white, 23, and a native of Shelby County, Kentucky, who was employed as a clerk by the L. & N. The mother also was white, 23, and a housewife who was born in Louisville, Kentucky. (Kentucky Birth Certificate 53938, Volume 108.) Shirley was named for James Bly Shirley, the deceased first husband of Mary's sister Eunice. His middle name Martin being Mary's maiden name. Called Shirley, which is an uncommon name for a boy, by his family and being of the same generation as the child movie actress Shirley Temple, Shag was teased considerably by other boys which created in him an aversion for his name and a pugnacious tendency. A close friend of Garnett's during their early years in Lexington,

Adolphus Julius Thomas, Jr., kiddingly called the youngster Shagnasty which, when recollected by his brother Bill in later wartime correspondence, was abbreviated to Shag and became his nickname.

Charles Kenneth Scroggins (K42) also was born at 112 West Oak Street, Louisville, Jefferson County, Kentucky, at 700AM on 14 December 1925. A male, he was identified correctly as the fourth child of the mother of which three were living. Dr. Hume was the physician with his office unchanged. The father Garnett F. Scroggins was white, 24, and a clerk at the L. & N. who was born in Shelby County, Kentucky. The mother Mary E. Martin was white, 23, a housewife and native of Louisville, Kentucky. (Kentucky Birth Certificate 63805, Volume 128.) Ken's names were selected because Mary liked them.

Sara Jeanne Scroggins (K43) was born at 625AM on 21 August 1928 at St. Anthony Hospital, Louisville, Jefferson County, Kentucky. A female, she was described as the fifth child of the mother, with four living. Although Mary named her second daughter after her mother Sarah Ramsey Martin, it was intended that her daughter's name be spelled Sara rather than Sarah. However the certificate spells it Sarah. The name Jeanne was selected by Mary at random. The attending physician was Dr. Hume of the same prior address. The parents lived at 2930 Southern Avenue in Louisville. The mother's name was erroneously entered as Mary Evaline Martin, white, 32, and a housekeeper born in Louisville, Kentucky. Both parents were residents of Lexington, Kentucky. (Kentucky Birth Certificate 1297, Volume 3.) Called Sonny by his parents as a child, when he started to school he elected to be known as Franklin which gradually supplanted Sonny as his name at home.

Patricia Ann Jones who married Bill Scroggins (K39) is the only child of Nelson Thomas Jones and Esther Jane Johnson. She was born in South Bend, Indiana, on 31 July 1925. Her step-father was Gerald Burdette Staples and she was known publicly as Pat Staples. Her family moved from South Bend to Louisville in 1941. Bill and Pat were married at the home of E. L. Jorgenson, minister of Highland Church of Christ, with Aviation Cadet Clarence E. "Chuck" Goodman as best man and Emily Hall as maid of honor. (Jefferson County, Kentucky, Marriage Bond 138.)

Sueno "Suzi" Okabe who married Shag Scroggins (K41) is a daughter of Yuma Okabe and Harue Yamashita. Born on 15 April 1930 on Shikoku Island in Japan, Suzi was married to and divorced first from Denis J. Paradis. Shag and Suzi had no children. Shag served in World War II as a private first class in the 75th regiment. His artillery unit went into combat against the Germans on Christmas Eve 1944 during the Battle of the Bulge. After 21 days on the line, his feet became frost-bitten and he was returned to the States for hospitalization. Retired from American Airlines, for whom he worked in Louisville, Los Angeles and San Diego, Shag lives in Lexington, Kentucky.

Gleta, who suffers from serious emotional disturbances for which she has received psychiatric treatment, divorced Ken on imaginary charges which he elected not to dispute. Their only child Suzanne Taylor Scroggins (L23) was born at 807AM on 06 April 1960 at Kentucky Baptist Hospital, Louisville, Kentucky, when the parents lived at 2000 Japonica Way, Louisville. She weighed 6 pounds, 4 ounces. The father was white, 34, a native of Kentucky and supervisor of the Casualty Department, Firemans Fund Insurance Company. The mother, who had been pregnant for 41 weeks, was white, 27, and a Kentuckian. (Kentucky Birth Certificate 16677, Volume 034.) Although Gleta was not a bad mother, she seemed to reject Suzanne from birth and paid little attention to the rearing of her daughter, which Ken did admirably.

Suzanne Scroggins (L23) married Jay Guin Patton on 22 September 1984 at Pisgah Church near Versailles, Kentucky. The couple dated steadily through high school and college. Suzanne attended the University of Kentucky from which Jay graduated. After marriage, they resided in Atlanta, Georgia, where they were ultimately divorced. Jay is the son of Ken's second wife Jane Cowen Strother. Ken and Jane were married at the Hunt-Morgan house in Lexington on 13 June 1981. His brother Bill was best man for Ken again. Bill's granddaughter Jennifer Scroggins was flower girl. Jane was married twice previously and divorced from both husbands. Ken and Jane reside in Woodford County, Kentucky. He is an officer of Purdy-Cooke Insurance Agency in Lexington, Kentucky.

Robert Ellsworth Guffy who married Jeanne Scroggins (K43) was a son of James Wilbur Guffy and Lena Anderson. He was born in Butler County, Kentucky, on 01 April 1924. Bob later attended the University of

Kentucky and was a member of the Phi Delta Theta fraternity. Jeanne and Bob were married at Highland Baptist Church in Louisville on 18 October 1952. In the absence of her father, her brother Bill gave her in marriage. Her brothers Ken and Shag were among the ushers. Pamela Ward Guffy (L24) was born at 1205PM CST on 04 August 1953 at Kentucky Baptist Hospital, Louisville, Jefferson County, Kentucky. The female child, who weighed 7 pounds, 4 ounces, was the first of the mother Sara Jeanne Scroggins, 2607 Broadmeade Road, Louisville, Kentucky. The mother, who was pregnant for 38 weeks, was white, 24, and a native of Louisville, Kentucky. The father Robert Ellsworth Guffy was white, 29, a native of Warren (sic) County, Kentucky, and a salesman for the Mengel Company. The attending physician was Silas H. Starr, 910 Heyburn Building, Louisville. (Kentucky Birth Certificate 40434, Volume 081.) Mary Page Guffy (L25) was born at 1159AM CST on 23 June 1956 at Kentucky Baptist Hospital, Louisville, Jefferson County, Kentucky. The female child, who weighed 7 pounds, 9 1/2 ounces, was the second child of the mother Sara Jeanne Scroggins, 313 Short Road, Louisville, Kentucky. The mother, who was pregnant for 40 weeks, was white, 27, and a native of Kentucky. The father Robert Ellsworth Guffy was white, 32, a native of Kentucky and a salesman for the Mengel Company. The attending physician was Edwin P. Solomon, 910 Heyburn Building, Louisville. (Kentucky Birth Certificate 35436, Volume 071.) Jeanne and Bob, who retired from the Container Corporation of America after a highly successful career, live in Lexington, Kentucky.

A graduate of the University of North Carolina and a member of Chi Omega sorority, Pam Guffy (L24) married William Harvey Hill, Jr. on 07 June 1975 at University Presbyterian Church, Chapel Hill, Orange County, North Carolina. They reside in Pinehurst, North Carolina, and have one child, Molly Rebecca Hill (M51), who was born on 23 August 1987 in Moore County, North Carolina. Pam is a successful interior decorator and Harvey is an entrepreneur in the home building business.

Page Guffy (L25), who graduated from Miami University of Oxford, Ohio, married Stuart Charles Woodward on 11 December 1982 in Winnetka Bible Church, Winnetka, Cook County, Illinois. They reside in Vero Beach, Florida, with their three children. Seth McGowan Woodward (M52) was born on 23 January 1986; Chas Anderson Woodward (M53) was born on 20 January 1988, both in Bethesda, Montgomery County, Maryland, and Sara Emmaline Woodward was born on 28 August 1997 in Florida

When her first child was born in 1960, Nancy was 16 and a half years old and her husband was 44. Six years later, she was a widow with three children.
