John Scrogin (E14) was a son of Samuel Scrogin (D5) and Elizabeth “Betty” Collins who migrated to Bourbon County, Kentucky, from Sussex County, Delaware, in 1794.¹ Rachel Kendrick was a daughter of Benoni Kendrick and Mary Warner who moved from Culpeper County, Virginia, to Bourbon County before 1795.²

The birth date of John Scrogin (E14) was recorded in the family register of his father:³

On 07 June 1819 Samuel Scrogin (D5) testified that he moved to Kentucky from Delaware in 1794:⁴

“... in the year 1794 I removed from the State of Delaware to Kentucky ...”

John Scrogin (E14) and Rachel Kendrick were married in Bourbon County, Kentucky, on 02 February 1808.⁵

John Scrogin (E14) was identified as John, Jr. on the 1810 census for Bourbon County, apparently to differentiate between him and his uncle John Scrogin (D2) who was identified as John, Sr. in the enumeration. John (D2) had a son John (E4) who was 36 years old in 1810

and, as far as is known, the second child and first son of John (E4) was not born until 1811: (Federal Census Microfilm 252, Roll 5, pages 68-113.)

John Scroggin (E14) served six months in the War of 1812, from 20 May through 19 November 1813, as a private in Captain Richard Matson's Company of Infantry, Mounted Regiment of Kentucky Volunteers commanded by Colonel Richard M. Johnson. His pay for the period was \$8 per month (\$48), plus 40 cents a day allowance for his horse (\$73.60), which totaled \$121.60.⁶ During his tour of duty, John Scroggin's unit fought in the Battle of the Thames on 05 October 1813. The Thames River is in southern Ontario, Canada, where it empties into Lake St. Clair.⁷

Kentuckians were prominent among those who fought to protect their homes from the British and Indians in the War of 1812, including men of the Scrogin family and their relatives. Robert Scrogin (E10) was 1st Lieutenant, Thomas Bohannon (Buckhannon) was 1st Corporal and Joseph Scrogin was a corporal in Matson's Company with John Scrogin (E14). The place of Private Joseph Scrogin, who volunteered as a substitute for Pittman Williamson and was promoted to Corporal, in the family has not been identified. One John Scrogin and a Robert Scrogin served as privates in Captain Virgil McCracken's Company of Riflemen, 1st Rifle Regiment commanded by Lieutenant Colonel John Allen from 12 August through 14 October 1812. Abraham Bohannon (Buckhannon), Seth Cook and Abraham Kesler of Shelby County also were privates in McCracken's Company. Although this roster stops at 14 October 1812, McCracken's Company fought at the Battle of River Raisin on 12 January 1813 where McCracken was killed and Abraham Bohannon, uncle of Pamela Bohannon Scrogin, was captured and later, with many other prisoners, murdered by the Indians. Perhaps contacts with Bohannon, Cook and Kesler during military service influenced John Scrogin (E14) to move to Shelby County from Bourbon County.

Leven Polk Scrogin (E7) was 1st Corporal in Captain Maurice Langhorne's Company of the 1st Rifle Regiment, Kentucky Volunteer Militia, with drummers Thornton Wilson, who married Rachel Kendrick's sister Mariah Kendrick, and Cumberland Wilson from 15 August 1812 through 14 October 1812. Thornton and Cumberland Wilson probably were brothers since Thornton J. Wilson later named a son Cumberland H. Wilson. Cumberland Wilson was married to Mary Parker in Woodford County, Kentucky, by D. Robinson on 02 April 1818.

Private Johnston Scrogin, who was in Combs' Company, Francesco's Regiment, probably was Robert Johnson Scrogin (F14). Private Mitchell Kendrick, first cousin of Rachel Kendrick Scrogin, was in Thomas' Company, Boswell's 10th Regiment, from 29 March to 28 September 1813. He was captured after "Dudley's Defeat" at Maumee River and forced to run the gauntlet between two lines of Indians which resulted in permanent crippling injuries. John Scrogin and George Scrogin served as privates in Captain Josiah Buskirk's, 3rd Regiment, Kentucky Mounted Volunteer Militia under Colonel James Allen from 18 September to 30 October 1812 in the expedition to Vincennes. They were discharged at

Busseron in Indian Territory, 180 miles from their home in Shelby County, Kentucky.⁸ John and George “Scrogin” probably were members of the Scoggin family that resided in Shelby County at that time.

In May 1813 Richard M. Johnson of Scott County, Kentucky, a member of Congress from Kentucky, was authorized to form a regiment of mounted Kentuckians to scout the Indian country from Fort Wayne to Lake Michigan, along the lake, then over to Illinois River and back to Ohio River near Louisville. Marching from Kentucky, the regiment made a rendezvous at Fort Winchester on 18 June 1813. During the reconnaissance Johnson’s regiment passed the battleground at River Raisin and buried the bodies of all of the Americans that they could find which had lain unburied where they had fallen in the massacre of 22 January 1813. Subsequently, General William Henry Harrison, in preparing for an invasion of Canada, called upon Governor Shelby of Kentucky to supply men for his expedition. The Kentuckians assembled at Newport on 31 July 1813. Colonel Johnson was directed to remain at Fort Meigs with his regiment until the main expedition could sail from the Portage across Lake Erie to Canada. Then Johnson was to march to Detroit and into Canada to meet the army. The Portage was on the shore of Lake Erie where Port Clinton is now located. The troops embarked on 20 September and landed near Malden, on the Canadian shore of the lake, on 27 September. On 01 October Johnson’s Regiment of Mounted Kentuckians entered Canada from Detroit and joined the expedition. The enemy, consisting of British regular soldiers, Canadian militiamen and Indians, elected to make their stand a few miles from Chatham within the steep banks where McGregor’s Creek joins the Thames River. Reconnaissance by personnel from Johnson’s Regiment on 05 October identified the deployment of the defensive forces on the north bank of the river. The position chosen by the British has been described as well-selected. On their left was the river with a high and precipitous bank and on their right was a marsh that ran almost parallel with the stream for about two miles. Between these, two or three hundred yards from the river, was a small, narrow swamp with a strip of solid ground between it and the larger marsh. It was so disposed as to easily flank Harrison’s left. The space between the river and the great swamp was covered with beech, sugar maple and oak trees, with very little undergrowth. The British Regulars were formed in two lines between the small swamp and the river and their artillery was set up in the road near the bank of the stream. The Indians were posted between the two marshes where the undergrowth was thicker. Oshawahnah, a Chippewa chief, commanded their right wing and Chief Tecumseh of the Shawnee commanded the left. In the disposition of his army for the attack, General Harrison placed Johnson’s Regiment in front. Since the British troops were drawn up in open order, General Harrison permitted Colonel Johnson, at his own request, to have one of his battalions charge them. This battalion, led by his brother, Lieutenant Colonel James Johnson, charged the British Regulars, broke the first line, scattering it in all directions, and continued against the second line, which it also penetrated. The Kentucky horsemen then turned and attacked the rear of the broken columns. Totally overwhelmed, the British surrendered as fast as they could throw down their arms. Within five minutes after the first shot was fired, most of the British troops were made prisoner. Having reviewed the rout from a distance, the British commander, General Proctor, fled the battle scene in his carriage.

Under the leadership of Richard Johnson, himself, the remaining battalion of his regiment moved against the Indians on the left almost simultaneously with the attack by the other battalion against the British. In order to reduce his casualties, Colonel Johnson called for twenty volunteers to attack the Indians with him and draw their fire so that the remainder of the unit could rush the enemy positions in relative safety while the Indians were reloading their weapons. One of the more moving aspects of this epic of heroism concerns William Whitley, one of the earliest pioneers into Kentucky, who volunteered to go with the decoys. Whitley, who was 63 years old and a former colonel of militia, could have had any command he desired in this expedition, even that of Major General. However he volunteered as a private soldier and retained that position by preference. There were only five survivors of the volunteers, later called "The Forlorn Hope." Led by Colonel Johnson and Whitley into withering gunfire, fifteen men were killed and four were wounded. Only one of them miraculously escaped unhurt. The old pioneer William Whitley was killed and Colonel Johnson was wounded.

Because of the thickness of the underbrush on this part of the battlefield, the mounted riflemen had to leave their horses and proceed on foot. The main body of the battalion charged into the Indians in the woods and brush, shouting the Kentucky battle cry, "Remember the Raisin!" The fierce hand-to-hand combat lasted for about eight minutes until the second wave under Donaldson moved in to support Johnson's troops. Under the fresh assault, the Indians soon gave up and fled in confusion.

Meanwhile, Major DeVall Payne and some sixty horsemen from Johnson's Regiment pursued General Proctor beyond Moravian Town. Proctor was so closely pursued that he abandoned his carriage in the road, mounted bare-back on one of his carriage horses and took through the woods. Twenty-four hours later he was sixty-five miles from the battleground. His carriage, sword and many valuable papers were captured. His government later censured him for abandoning his command. Major Payne's men, in their pursuit of Proctor, took prisoners and captured valuable spoils including three brass cannons that had been taken from the British by the Americans at Burgoyne's surrender at Saratoga in 1777 and later recaptured by the British at Hull's surrender. One of them is on display at the Kentucky Historical Society.

The losses in the action were not large, that of the Americans being about fifteen killed and thirty wounded. The British lost eighteen killed, twenty-six wounded and six hundred prisoners, including twenty-five officers. In their retreat from the field of battle, the Indians did an unusual thing for them and left some of their dead behind, so it is known that, at least, they lost thirty-three warriors. The great Indian leader Chief Tecumseh was among those killed but his body was removed by the Indians.

The victory at the Thames ended the campaign, broke the British and Indian alliance and established American control of Michigan Territory.

On 07 October 1813, two days after the battle, the Kentuckians began their return March home. John Scrogin (E14) was discharged from his regiment on 20 November 1813:⁹

This is to make it known to whom it may concern that John Scroggin a soldier in Captain Richard Matson's Company composing a part of the Regiment under my command has served his country the period of six months and this is the evidence that said John Scroggin is entitled to a tour of duty for the said period; and in testifying the honorable services of said John Scroggin in having acted the part of a brave soldier; the Commandant of said Regiment takes this last occasion to return to the Officers and Men his sincere thanks for their faithful services - for their ready acquiescence in his commands, and for the fortitude with which they submitted to privations and hardships, and to congratulate them on the termination of their services, which was as brilliant as the commencement was patriotic.

John Scroggin (E14) was residing in Bourbon County in 1820:¹⁰

This tabulation is incorrect. John and Rachel had six children by 1820 but the count was two boys and four girls. Elizabeth should have been listed as over ten years. The third son probably should have been the fourth daughter. Samuel Scroggin appears in the age group of 10 and under in 1810 and 1820, probably because he was born just before the census was taken in 1810 and had not reached his tenth birthday when the census was enumerated in 1820.

By 1825, John Scroggin (E14) was living in Shelby County, Kentucky. In 1798 Samuel (D5) and Betty Scroggin sold 100 of the 200 acres that they owned on Townsend Run in Bourbon County to their son Robert Scroggin (E10) for five shillings.¹¹ In 1818 Samuel conveyed the remaining 100 acres to son George (E11) for \$600.¹² Since Robert (E10) got 100 acres of his parents' land for 5 only shillings, he must have been the eldest surviving son with the right of primogeniture to his father's land. Joseph Scroggin (E9) must have died before Joseph Collins Scroggin (E13) was born in 1785, considering the re-use of the name Joseph. No records have been found pertaining to Joseph Scroggin (E9), Joseph Collins Scroggin (E13) or Samuel Scroggin, Jr. (E15) in Bourbon County, so they all probably died young.

Since John Scroggin (E14) did not share in the previous division of his parents' land, the family apparently decided in 1825 to make an arrangement giving John equity with his brothers. On 05 September 1825 Robert Scroggin of Bourbon County conveyed 102 acres and 17 poles in Bourbon County on the waters of Silas Run to John Scroggin of Shelby County for \$642.¹³

This Indenture was made on this 5th day of September in the year of our Lord, 1825 between Robert Scrogin of the County of Bourbon and the State of Kentucky of the one party and John Scrogin of the County of Shelby in the State aforesaid of the other party. Witnesseth that ... Robert Scrogin for ... \$624.00 lawful money of the United States ... paid by ... John Scrogin ... has ... sold ... unto the said John Scrogin one certain tract ... of land ... in the County of Bourbon and on the waters of Silas Run ... Beginning ... corner to John E. Shropshire and Robert Griffith ... by my own land ... Jacob Coils line ... corner to L. Corbin ... with said Corbin and Joseph Shropshires line ... to John E. Shropshires line ... to the beginning containing 102 acres and 17 poles ...
Robert Scrogin

The deed was acknowledged by Robert Scrogin in Bourbon County Court on 05 September 1825 and produced for record on 30 November 1825.

The likelihood that this deed was based on sibling parity is substantiated when in the following year John and Rachel Kendrick Scrogin sold this land for \$2042, making a profit of \$1400.¹⁴

Shropshire ... to the beginning ... In the binding whereof the said John Scrogin and Rachel Scrogin his wife have hereunto subscribed their names and affixed their seals the date above.

This deed of bargain and sale from John Scrogin and Rachel his wife to John E. Shropshire being acknowledged before me on the 1st day of June last by the said Scrogin and wife to be their act and deed and the said Rachel being examined by me privately and apart from her husband declared that she did freely and willingly deal and deliver this deed themselves and explained to her and wished not to retract it and consented that it might be recorded and the same being this day produced to me forever and duly recorded in my office.

John Scrogin (E14) was enumerated on the 1830 federal census in Shelby County, Kentucky, on the north side of the road from Frankfort to Louisville:¹⁵

This indicates that Rachel died after 1830 and before 19 October 1835 when John Scrogin (E14) married his second wife, the widow Margaret Baldwin:¹⁶

We, the undersigned, are jointly and severally held and firmly bound unto the Commonwealth of Kentucky, in the sum of L50 to be made and levied of our respective goods, chattels, lands and tenaments, and for the use of the Commonwealth upon the condition that there is no lawful cause to obstruct the marriage of John Scrogin and Mrs. Margaret Baldwin, a widow.

The date of return must be an error and probably should read October instead of September. The minister Abraham Cook preached at Indian Fork Baptist Church near Bagdad, Kentucky.

On the next day, 20 October 1835, Thornton J. Wilson, husband of Mariah Kendrick and brother-in-law of the recently deceased Rachel Kendrick Scrogin, conveyed land to the children of Rachel Kendrick and John Scrogin:¹⁷

This Indenture made this 20th day of October in the year of our Lord one Thousand eight hundred and thirty five between Thornton J Wilson of the County of Boone and State of Kentucky on the first part and Elizabeth Moore Samuel Scrogin Benoni

Scroggin Irene Miles Polly Vardeman Sally Tharp of the County of Shelby and State of Kentucky of the Second part witnesseth that the Said Thornton J Wilson for ... the Sum of fifteen hundred dollars ... hath ... Sold ... unto ... the Said parties of the Second part ... all that tract or parcel of land Situate ... in the County of Shelby on the waters of Six mile containing one hundred and eighty nine acres & 145 poles and bounded as follows to wit beginning a Stone in Joseph Floods line thence N3 1/2 W111 poles to a Stone in Sd Floods line thence N2 1/2 W133 poles to two beeches and sugartree thence S87 1/2 E129 3/4 poles to a hickory Thence S1 E120 poles to three beeches crossing The Creek at 32 and 86 poles thence on the Same Course and line 118 poles to three beeches Thence S89 1/2 W123 poles to the beginning ... In witness whereof the Said party of the first part hath hereunto Set his hand and Seal the day and date first above written

The clerk who transcribed this deed into the record book misspelled the name of Polly Vardeman as Tolly. It is pertinent to note that the Kendrick side of the family apparently considered Benjamin Scroggin to be named Benoni for his maternal grandfather Benoni Kendrick.

Thornton Wilson resided in Bourbon County, Kentucky, when he bought this land on 15 December 1828 from William and Rhoda Miles of Weakley County, Tennessee, for 1500. It was described as containing 189 acres, 3 roods and 25 poles in Shelby County on Six Mile Creek and included Radcliffe's mill dam.¹⁸ Perhaps the purchase was funded by Benoni Kendrick, who lived with Thornton and Mariah Wilson in Bourbon County in 1820.¹⁹ Benoni Kendrick died before 01 November 1830 when Thornton J. Wilson was appointed to administer his estate with Robert Scroggin (E10) as his security.²⁰ Benoni Kendrick probably transferred all of his assets to Thornton Wilson before applying for a Revolutionary War pension in 1818 when he declared that he was in "reduced circumstances."²¹

Since no record has been found of John Scroggin (E14) having owned land in Shelby County, perhaps he lived on the Wilson tract there under some sort of a familial agreement with his brother-in-law against a background of a mutual legacy of their wives. Although there is no

statement in the deed to that effect, the timing suggests that it is another conveyance made to equalize an estate distribution. Since he sold it to them for what it cost him, Thornton Wilson apparently had some obligation to his nephews and nieces.

Benjamin (F45) and Samuel (F90) Scrogin acquired their sisters' shares of this land for \$780 by a deed dated 01 October 1845:²²

This Indenture made this first day of October in the year One thousand eight hundred and forty five between John More and Elizabeth Moore his wife daughter of John Scrogins, Abraham Miles and Irean Miles his wife daughter of John Scrogins, Peter Vardeman and Mary Vardeman his wife daughter of John Scrogins, and Joshua Tharp and Sallie Tharp his wife daughter of John Scrogins of the County of Shelby and State of Kentucky of the one part and Benjamin Scrogins and Samuel Scrogins of the County and State aforesaid of the other part witnesseth that the said John Moore and Elizabeth More his wife, Abraham Miles and Irean Miles his wife, Peter Vardeman and Mary Vardeman his wife and Joshua Tharp and Sallie Tharp his wife for ... seven hundred and eighty dollars in hand paid viz; to John Moore two hundred dollars, to Abraham Miles one hundred and ninety dollars, to Peter Vardeman one hundred and ninety dollars and to Joshua Tharp two hundred dollars ... hath ... sold ... unto ... Benjamin Scrogin and Samuel Scrogin ... all their undivided interest to a tract of land which was deeded to the heirs of John Scrogins by Thornton Wilson situate ... in the County of Shelby on the waters of Six Mile and bounded as follows ... containing 189 acres 3 roods 25 poles ... in witness whereof the said John Moore together with Elizabeth More his wife, Abraham Miles together with Irean Miles his wife, Peter Vardeman together with Mary Vardeman his wife and Joshua Tharp together with Sallie Tharp his wife doth hereby relinquish their right of title in and to the lands conveyed in the deed hath hereunto set their hands and seals the day and date first above written.

There were no witnesses given. The boundaries were identical to those in the Wilson deed.

Unless it was intended to mean "heirs of Rachel Scrogins, widow of John Scrogins," the term "heirs of John Scrogins" must have been used in the sense of "children of John Scrogins" or "heirs-to-be" since John was alive at the time of writing. Shortly after their marriage in October, John Scrogin (E14)) and his new wife Margaret went to Morgan County, Indiana, where he entered 40 acres on 20 December 1835.²³ Morgan County, Indiana, is directly southwest of Indianapolis and adjoins Marion County. The county seat is Martinsville. The county is traversed from the northeast to the southwest by the White River. On 20 December

1835 John entered 40 acres there which were the northeast quarter of the northwest quarter of Section 32, Township 12, Range 2 East..²⁴ He acquired this land through a Federal patent:²⁵

Section 32 lies east of Martinsville and southwest of the town of Cope, Indiana. Clear Creek runs through the section, just east of the center line, and flows north into White River.²⁶

On 08 January 1836 John Scrogin conveyed his Morgan County land to Ebenezer Henderson on a warrant deed for \$50. The deed was acknowledged in court on the same day and recorded.²⁷ This must have been a mortgage because on 20 September 1838 Ebenezer Henderson and his wife Cynthia sold the tract to Margaret Scrogin for \$50. They acknowledged this deed in court on the same day and it was recorded.²⁸

Ebenezer Henderson had a tract adjoining John Scrogin on the west in Morgan County. On 06 April 1833 he entered the 40 acres of the northwest quarter of the northwest quarter of Section 32.²⁹ This contact and others with members of the Henderson family suggest that the

maiden name of Margaret "Peggy" Baldwin Scrogin may have been Henderson. James C. Henderson, who was surety on the marriage bond for John Scrogin and Margaret Baldwin, may have been her father or brother. Jephtha Henderson, who was in Iowa with John and Peggy when John wrote home to Kentucky in 1850, had the land adjoining John Scrogin (E14) on the east in Morgan County. By a warrant deed dated 27 February 1847 he purchased for \$275 the 40-acre northwest quarter of the northeast quarter of Section 32 from Robert H. Scrogin (F53), son of Joseph Scrogin (E21), who was a first cousin of John Scrogin (E14). The deed was acknowledged on 26 November 1847.³⁰

John Scrogin (E14) had two sons by Peggy (Henderson?) Baldwin who were born in Indiana before 1840. John B. Scrogin (F91) was born about 1836 and Francis Marion Scrogin (F92) was born about 1838. The 1840 census for Morgan County, Indiana, indicates that Peggy Baldwin had at least two daughters before she married John Scrogin.³¹

Elizabeth Baldwin and Jephtha Dulin (Dewling) obtained a marriage license on 17 October and were married on 18 October 1844 by Hiram T. Craig.³² Jephtha Dulin (Dewling) bought the 40-acre northwest quarter of the southeast quarter of Section 34, Township 12, Range 2 East from William Hess on 22 February 1848 for \$135. The deed was recorded on 23 September 1848.³³ Jephtha Dulin (Duling) sold this tract to Benjamin Speake on 08 October 1848 for \$150. The warrant deed was recorded on 17 July 1849.³⁴

Jephtha Dulin, who also was in Iowa with John and Peggy Scrogin in 1850, may have been related to Moses Dooley (Dooly), who married Elizabeth Bohannon in Shelby County, Kentucky, on 24 April 1823.³⁵ Elizabeth was a daughter of John Bohannon, Jr. and Polly Sacra.³⁶

On 04 March 1849 John Scrogin (E14) and his wife Margaret Scrogin (Margrette Schroggan) sold the 40 acres in Morgan County on a warrant deed for \$330 to Thomas F. and Sarah Huff. John signed the deed as John Scrogin and Margaret made an X mark where her name was written Margaret Schroggan. They acknowledged it in court on 24 March 1849.³⁷

Joseph Scrogin (E21) was enumerated in Morgan County in 1840:³⁸

Joseph Scrogin (E21), who was a son of Robert Caldwell Scrogin (D7) and Ann

Culver, was married to Martha Campbell.³⁹ Joseph died in Morgan County, Indiana, on 25 May 1841 and his obituary was printed in a Kentucky newspaper on 06 July 1841:⁴⁰

Jos. Scrogin, 53, formerly of Franklin County, died in Morgan County, Iowa.

There is no Morgan County, Iowa; a prophetic error, perhaps, since nine years later his cousin John Scrogin (E14) moved from Morgan County, Indiana, to Clayton County, Iowa.

In 1850 John and Peggy Scrogin went to Iowa to claim a land grant for his service in the War of 1812. On 15 August 1850 John wrote from Iowa to his children in Shelby County, Kentucky, saying that they arrived in Iowa on 08 April and had rented a house and land about four miles from McGregor's Landing on the Mississippi opposite Prairie de Chien, Wisconsin, while waiting for his bounty land warrant. The letter remarks about Peggy wanting to go to Indiana; sends greetings to Uncle Bill Bohannon in Kentucky; and refers to John and Marion, Jephtha Henderson and his wife and mother, and Jephtha Dulin and his wife, as being with them. The writing and the signature are by the same hand:⁴¹

August 15th 1850

My deare children I wonce more make the attempt to wright two you All to let you heare that I am well at this time and all the rest of the family thanks be to the good lord for his tender mercies Jephtha and his mother has Entered One hundred and Sixty Acres of land With the best Spring water on it that I ever Drank it runs Cold and fresh and is so cold it is timbered land and is about four miles from McGregors landing on the mississippi Oposit prarie duchien it is a prarie country About 6 or 7 miles from the river with timber in places and around it I have cut forty house logs last Spring after the woods was burned but the weeds and bushes is as high as my head and So thick that it is with diffuculty that a person can get a long I want to get the logs haled and put up as soon as I can before cold weather Sets in we landed the Eighth Day of April in Iowa we rented a house and Some ground 3 or 4 acres our truck patch and Corne is good altho the Storm tore it all to peices Jep henderson has a house and Some Corne and a truck patch we have a field of Corne on the prarie of tenn or twelve Acres that is tollerable good

I wish you to wright as quick as you can as I want to hear from you as Soone as possible I have not my land warrant yet as it has only pased the lower house If I get any it will be 80 Acres as I Served Six months only peggy talks Very mutch of going to indiana next Spring if the lord is willing and we Should all live and have our health John and Marion Will be with us I am well pleased with the Country this far there is Some deer and Some bear and wolves I killed one deer and one large koone Some birds and Squirels feasents Give my Compliments to all the inquiring friends I way 180 pounds in my Shirt Sleeves tell uncle Bill Bohannon that I am the Same Old John Scrogin yet and friend that I never was hartier in my life tho Afflicted with pains in the upper Jouint of my right thigh Jephtha hendersons wife has a nother Son Jephtha dulins wife has a nother Son also No more at present But Sill remain your Ever loving Old father while I live here on this Earth and after this earthly tabernicle is also

(illegible word) I hope to meet you all at the house that is not made with hands
Eternal in the heavens and not my friends only But all the human family

Written on a single sheet of paper, folded so as to make two pages, the letter was folded twice again and sealed with the address and postmark on the outside:

It was postmarked, Prairie Du Chien Aug 21.

Jane Catherine Scrogin (G65) practiced her penmanship by copying some of the script and writing her name in blank spaces on the paper. Jane was a daughter of Benjamin Scrogin (F45). Someone, probably Sciota Young Scroggins, wrote on the outside of the folded letter:

W. B. Scroggins's Great Grandfather

Another early settler of Clayton County, who arrived there in 1851, described the town of McGregor as then a hamlet of five or six small buildings. He said that the spring of 1851 was one of the wettest ever known. The prairie between Chicago and Elgin was half under water. The railroad track was newly laid, unballasted and indifferently graded, with ties laid on the prairie sod in some places. The fastest speed was ten miles per hour and frequently little faster than a man could walk. Traveling by rail was tedious, but traveling by stage was exhaustive and described by some as paying for the privilege of wading through mud on foot with a rail on the shoulder with which to pry up the coach when it was stuck.⁴²

The town of McGregor is in northeastern Iowa on Mississippi River opposite Prairie du Chien, Wisconsin, just north of where Wisconsin River enters the Mississippi. Located in Clayton County, McGregor is not far from Fort Atkinson, an outpost of the 1840's that has been restored; Effigy Mounds National Monument, where the Indian mounds are in the shapes of birds, snakes and mammals; Pikes Peak and Echo Valley State Scenic and Recreational Parks; and Spook Cave. Clayton County is drained by Turkey River which flows into the Mississippi about half-way between McGregor and Dubuque, Iowa, to the south. The wooded hills and river bluffs of northeastern Iowa break the level plains of the state which contains one-fourth of the highest grade tops oil in the United States. A series of highways and byways known as Great River Road follow the Iowa bank of the Mississippi from the Minnesota border south to Dubuque. It follows one of the most dramatic stretches of the river's entire length. Located near Marquette, Iowa, north of McGregor, Effigy Mounds

National Monument is situated on soaring bluffs above the river. Just south of McGregor, Pikes Peak State Park also has Indian mounds, a cave, a falls and colorful sandstone cliffs.

Shortly after John wrote home, he was enumerated on the federal census in Mendon Township, Clayton County, Iowa, 23 August 1850:⁴³

Although the sale of land to a pair of 16- and 14-year-old boys seems highly unusual and hardly legal, John (E14) and Margaret Scrogin sold his bounty land, the south half of the southwest quarter of Section 4, Township 94, in Clayton County, Iowa, to their sons John B. Scrogin (F91) and Francis M. Scrogin (F92) on 08 May 1852 for \$100:⁴⁶

This Indenture Witnesseth: That John Scrogin and Margaret Scrogin of the County of Clayton and the State of Iowa, in consideration of One Hundred Dollars to us paid by John B. Scrogin and Francis M. Scrogin of the County and State aforesaid, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey to the said John B. Scrogin and Francis M. Scrogin, their heirs and assigns forever, the following real estate in Clayton County and State of Iowa, and described as follows to wit: The South half of the South West quarter of Section Four in Town Ninety four, Range three west of the principal meridian, containing Eighty acres more or less, together with all the privileges and appurtenances to the same belonging. To Have and To Hold the same to the said John B. Scrogin and Francis M. Scrogin their heirs and assigns forever, the Grantors their heirs and assigns, hereby covenanting with the Grantees their heirs and assigns, that the title so conveyed is clear free and unencumbered, and that they will Warrant and Defend the same against all legal claims whatsoever.

On the same day Margaret Scrogin bought the 80-acre north half of the southeast quarter of Section 5 in Township 94, Range 3 West, from Jeptha Henderson and his wife Matilda Henderson for \$100. Both signed the deed before witnesses Lewis Sturm and V. R. Miller.⁴⁷ The north half of the southeast quarter of Section 5 and the north half of the southwest quarter of Section 4, Township 94, Range 3, Iowa, were located by Jeptha Henderson on 16 April 1850 with Bounty Land Warrant 44818 and the United States patent for them was issued to him on 10 July 1851.⁴⁸

The 1852 land transactions of John and Margaret Scrogin apparently reflect the plans made by the aging John for his wife and children in Iowa before making a trip back to Kentucky to visit his first family. Perhaps Peggy went with him as far as Indiana, according to her desires expressed in his letter, and by transferring title to their sons before they left, they avoided legal difficulties that might have arisen from their failure to return. John got back to Shelby County to see his children there. Christine Fry Merchant, of Bagdad, Kentucky, had a vague recollection in 1975 of a story she heard as a child about the day that “old man Scroggins came back to Kentucky, riding in alone on his horse.”

John did not return to Iowa. On 18 May 1855 Margaret Scrogin of Clayton County, Iowa, applied for another bounty land grant as a widow, stating that her husband John Scrogin had died at Christiansburg, Kentucky, on 22 June 1855. Other documents in the file support the date of application, so the year of John’s death must have been 1853 or 1854.⁴⁹

Robert R. Read, Clerk of the District Court at Garnavillo in Clayton County, certified that Andrew Anderson was a Justice of the Peace on 21 May 1855. On 23 August 1855 at Shelbyville, Kentucky, Hector A. Chinn, Clerk of Shelby County Court, certified that the records in his office showed that John Scroggan and Margaret Baldwin were married on 19 October 1835 by A. Cook, a minister of the Gospel.

Margaret was allowed 80 acres on 07 November 1857. Her specific claim for land and her eventual disposition of it has not been determined but it may have been the north half of the southeast quarter of Section 5, Township 94, north of Range 3 west of the 5th prime meridian, in Clayton County. A deed by which she obtained this land has not been found in Clayton County but she sold it to Peter Fisher on 24 June 1861 for \$800.⁵⁰

John Scrogin (E14) and his first wife Rachel Kendrick are presumed to be buried in the Scroggin graveyard on the farm owned by Less Johnson in 1973. It is situated about 2.5 miles north of Bagdad in Highway 395 and about 1/2 mile south of where the road crosses Six Mile Creek. Their sons Benjamin (F45) and Samuel (F90) Scrogin owned this land and

had a mill near where the road crosses the creek. Samuel (F90) and his wife Malinda Miles are buried there with engraved stones marking their graves.⁵¹

The only other stone there is for Mahala, daughter of G. F. & Sarah Moore, who was born on 08 August 1858 and died on 03 May 1863. Their relationship to the Scrogin family is not known.

Benjamin Scrogin (F45) is buried in the cemetery at Indian Fork Baptist Church with his wife Pamela Bohannon Scrogin. His tombstone gives a birth date of 24 January 1811 which conflicts with Samuel's birth date of 14 June 1810. Since John Scrogin (E14) and Rachel Kendrick were married on 02 February 1808 and had a daughter Elizabeth first, about 1809, the birth date of Samuel may be accurate with Benjamin being born either 24 June 1811 or 24 January 1812.

This area of Shelby County, which is now served by the Bagdad Post Office and known as Bagdad, was previously served by a post office at Christiansburg and generally known as Christiansburg. The present community of Christiansburg is 10 miles northeast of Shelbyville, the county seat. Incorporated on 01 January 1824, Christiansburg had two churches, Baptist and Methodist, two physicians, two taverns, four stores and groceries, a steam sawmill, a woolen factory and four mechanics shops in 1873. In a story written about Shelby County that year, Bagdad, Jacksonville and Consolation were described as small places. All four are on the ridge dividing the watershed of the county. Land northeast of the ridge is drained by Benson Creek, Six Mile Creek and the Indian Fork of Six Mile into the Kentucky River. The Scrogin land was at the junction of Indian Fork and Six Mile creeks. Most of the county is drained into Salt River to the south by Clear, Beech, Brashears, Bullskin, Fox Run, Plum, Gist, Long Run and Floyd's Fork creeks.

Shelby County was the 12th county formed in the Commonwealth of Kentucky and the third established after Kentucky was admitted to the Union. Created in 1792 from Jefferson County, it was named for Isaac Shelby, the first, and then, governor of the state. The first station established by a white man in the area that is now Shelby County was built by Squire Boone in 1779. Situated on Clear Creek at the Painted Stone, the location of the station is now within the limits of the city of Shelbyville. For nearly two years, Boone's Station was the only one between Harrodsburg, and its surrounding small stations, and the large fort at the Falls of the Ohio, with its small satellite stations along Beargrass Creek. In September 1781, Boone's Station was abandoned temporarily after Indians began making frequent appearances in the neighborhood and there was an attack. Fleeing to the stronger settlements at Louisville, the little band of pioneers were attacked by a large group of Indians near Long Run Creek with a loss of 100 white persons, men, women and children killed or captured, including two daughters of John and Sarah Scoggin Hansborough who lived at Boone's Station at the time. Learning of the massacre, Colonel John Floyd and Captain John Holder

led 37 men after the Indians but they were ambushed by 200 warriors who killed 16 of the pursuing Kentuckians. Only 9 or 10 Indians died in the engagement. Boone's Station was not re-occupied until about Christmas 1781. In 1783 when he was serving in the Virginia legislature, Squire Boone transferred his station to Colonel Lynch and it was thereafter known as Lynch's Station. Other early settlements in the Shelby County area were the station of Captain Robert Tyler on Tick Creek, Owen's Station built in 1782 by Brackett Owen, Colonel Aquila Whitaker's Station on Clear Creek and Captain Samuel Well's Station.

Squire Boone was the brother of Daniel Boone and of Sarah Boone who married John Wilcoxson. Jane Wilcoxson, granddaughter of John and Sarah Boone Wilcoxson, married William Bohannon and had Pamela Bohannon who married Benjamin Scrogin (F45).

Six miles east of Shelbyville there is an ancient Indian fortification situated on a hill some 200 feet above the surrounding terrain with a view for miles around. A double ring of earthworks from 4 to 8 feet high encircled several wooded acres watered by a spring. Graves and Indian relics have been found in the vicinity.

On 08 March 1856 John Scrogin (Scroggins) of Clayton County, Iowa, bought for \$93.50 from William Joshua Barney and Georgianna F. Barney of Dubuque County, Iowa, the southwest quarter of the southeast quarter of Section 4 in Township 94 North of Range 3 West of the 5th prime meridian.⁵² John Scrogin (Scroggins), who signed the deed with an X mark, sold the southwest quarter of the southeast quarter of Section 4, Township 94, Range 3 west, in Clayton County, to F. Larned for \$300 on 08 October 1856.⁵³ These deeds must pertain to John B. Scrogin (F91), although he used his middle initial on all subsequent court transactions. It is likely that the B. stood for Baldwin.

Margaret Scrogin was living with her son John in Mendon Township, Clayton County, Iowa, on 19 June 1860:⁵⁴

John B. Scroggins (F91) was shown with real estate valued at \$400 and personal property worth \$100. Margaret was credited with real estate valued at \$800. Her birthplace of Kentucky and age of 56 do not coincide with the 1850 census, which showed her as born in South Carolina and aged 49. Since she represented herself as 55 in 1855 when she applied for the bounty land, she probably was 59 or 60 in 1860.

Julia Ann Baldwin (Scrogin) married William Minney before 1860 and was tabulated with her husband. Francis Marion Scrogin (F92), who was not listed on the 1860 census as a head of household in Mendon Township, must have been living with another family. The records

of Clayton County do not show a marriage for Julia Ann Baldwin (Scrogin), John B. Scrogin or Francis M. Scrogin.⁵⁵

On 24 February 1859 John B. Scrogin (F91), his wife Ruth Ann and Francis M. Scrogin (F92), all of Clayton County, sold to G. S. C. Scott and Henry C. Scott of the firm of Scott and Brother, for \$300, the southeast quarter of the southwest quarter of Section 4, Township 94, Range 3 west.⁵⁶

The fact that Frances Marion Scrogin (F92) did not have a wife to sign the deed, suggests that he was not married by 1859.

On 29 May 1863, by a deed of quit claim, John B. Scrogin of Clayton County conveyed to Margaret Scrogin of the same place, for \$169, the southwest quarter of the southwest quarter of Section 4, Township 94, North of Range 3, west of the 5th prime meridian, in Clayton County. He signed with an X.⁵⁷

On 26 August 1865 Margaret Scrogin and John B. Scrogin (Scroggins) sold to Patrick Hynes, for \$400, the southwest quarter of the southwest quarter of Section 4, Township 94, north of Range 3, west of the 5th prime meridian. The deed was acknowledged by Margaret and John B. Scrogin on the same date at McGregor in the office of Thomas Updegraff, a notary public.⁵⁸

The relationships of John Scrogin (E14), his second wife Margaret Baldwin and their children, Elizabeth Baldwin, who married Jephtha Dulin; Julia Ann Baldwin, who married William Minney; John B. Scrogin (F91); and Francis Marion "Dick" Scrogin (F92); are proved by depositions, which state that Ruth Ann Scrogin, the wife of John B. Scrogin, died before 29 August 1865 and that she had no issue. Elizabeth Baldwin Dulin died before 27 May 1858, when Jephtha Dulin was described as a widower. The record also states that Margaret Baldwin Scrogin "left here" after 24 July 1861, but it is not understood if it meant that she left Mendon Township, Clayton County or the state of Iowa. She was signing deeds in Clayton County in 1865:⁵⁹

That the name of John B Scroggin sometimes called Scroggins is correct. he was the son of John Scroggin & Margaret Scroggin & there was no other John except John the Father & John B the son. That Margaret Scrogin who was grantee and Margaret Scroggin grantor in deeds of NE of SE & NW of SE

5.94.3. is one and the same person. That the grantors in deed of SE SW 4.94.3 dated Feby 24th 1859 are the same identical persons who were grantees in deed of same land dated May 8th 1852. That Rutha Ann or Ruth Ann Scroggins was the wife of John B Scroggins and I am pretty certain died without having any children.

The statement about literacy probably applied to Margaret and her children, who were the principals in most of the subject deeds, but John Scrogin could read and write, as indicated by his letter to his son, Benjamin, on which the signature matches John's signature on other public papers.

Ruth Ann, the wife of John B. Scroggins (F91), was a daughter of Edmond and Mary Keeling of Polk County, Missouri. (Clayton County, Iowa, Deed Book 50, page 549.)

Scrogin (Scogins) of Clayton County, Iowa, for \$1.00, the southwest quarter of the southwest quarter of Section 4, Township 94, Range 3 west of the principal meridian, containing 40 acres. The quit claim deed was signed Edmond Keeling and Mary X Keeling.

Edmond Keeling and his wife Mary acknowledged the deed and she relinquished her dower right in the property in Polk County Court, at Bolivar, Missouri, on 12 June 1863.⁶⁰

William and Julia Ann Minney of Clayton County, who signed the deed with their marks, sold the southwest quarter of the southeast quarter of Section 5, Township 94, to G. W. Hampshire, for \$240 on 31 August 1861.⁶⁴

William Minney bought the southwest quarter of the southeast quarter of Section 5, Township 94, of Range 3 West in the Dubuque Land District from Francis and Lucy Daniels for \$66.00 on 06 March 1854.⁶⁵

William Minney, who married Julia Ann Baldwin, was born in New York of Canadian parents. William and Julia Ann probably were married about 1855, because they had sons aged 4 and 1 in 1860. They resided in the town of McGregor, Clayton County, Iowa, when the census was taken on 12 June 1860. Jeptha Dulin, or one of his relatives, lived with them.⁶⁶

The parents of William Minney, who had personal property worth \$300, were of foreign birth. He and Julia Ann were tabulated as being unable to read or write.

Julia Ann Baldwin Minney apparently died before 07 June 1880, when William Minney of Mendon Township, Clayton County, Iowa, was described as a white, male laborer and widowed boarder, aged 52, who was born in New York to Canadian parents.⁶⁸

George O. Minney was born in Iowa in May 1859. A resident of McGregor City, Mendon Township, Clayton County, his father was shown as a native of Canada and his mother of New York on the census. He had been married for 12 years by 12 June 1900.⁶⁹

John Minney (Minnie), who was born in Iowa in July 1864, was recorded as a child of parents who were born in New York. John had been married for 7 years in 1900.⁷⁰

Margt. Moore, aged 8, who was listed as a male, undoubtedly should have been tabulated as a female. Her age may be wrong, too, unless she and John Ezra were twins.

James B. Shuck, aged 25, born and residing in Shelby County, and Edney Ann Moore, daughter of John Moore, aged 18, born and residing in Shelby County, were married on 26 October 1859, with W. J. Stivers as bondsman.⁷⁴

There undoubtedly were some children born to Elizabeth Scrogin Moore between John Moore, Jr. about 1828 and Edna Ann Moore about 1841.

Elizabeth Scrogin Moore (F70) probably died after the 1860 census and before 18 June 1861 when John Moore appears to have married again. On that date John Moore of Shelby County; aged 59; 2nd marriage; farmer; born Henry County, Kentucky; parents born Virginia; married S. Frances Dowden of Shelby County; aged 21; 1st marriage; born Henry County; father Willis Dowden, who was bondsman, born Shelby County; mother born Woodford County.⁷⁵

Owen Moore (G300) and Ina Bella Edrington are buried in Section P of Frankfort Cemetery in Frankfort, Kentucky.

Malinda Miles who married Samuel Scrogin (F90) on 22 December 1832 in Shelby County, Kentucky, reputedly was a daughter of a Samuel Miles.⁷⁶

It was reported that Samuel Scrogin (F90) died at home in Shelby County on 08 October 1849.⁷⁸

Memorandum that on the 8th day of October 1849 Samuel Scroggin of the County of Shelby being sick of sickness whereof he died on the same day to wit the 8th day of October 1849 at his dwelling house in said county did make and declare his last will and testament non cupative in these or words of like substance that is to say "I want you (his wife) to take my property It is for you and my children." These words or to the like effect the said Samuel Scroggin deceased in the presence of the subscribers with intention that the same should be his last will and testament. The undersigned witness Benjamin Scroggin states further that in addition to the above testamentary words, he heard the said Samuel Scroggin say "as long as you live or remain single" and then he added "will that do?" James Miles one of the subscribing witnesses says he distinctly heard this last sentence "will that do?" The above is the substance of what the said Samuel Scroggin said on the day above mentioned which we have reduced to writing this 13th day of Oct. 1849.

This day came Malinda Scroggin & on her motion & she having taken the oath required by law & entered into bond with James Miles and Abram Miles her security in the penalty of \$3000 conditioned as the law directs letters of administration is granted to her with the non cupative will annexed of Samuel Scroggin dec'd in due form of law.

However his tombstone shows that Samuel Scroggin died on 09 October 1849. As her brother-in-law and next-door-neighbor Benjamin Scroggin (F45), Malinda Miles does not appear on the 1850 census. A few years later the surviving family of Samuel Scroggin (F90) were named in a deed:⁷⁹

This Indenture made this 27th day of September 1854 between Malinda Scroggin widow of Samuel Scroggin dec'd Harvey Bohannon and Cynthia Ann his wife Nancy Scroggin Irene Scroggin and John S. Scroggin, Francis M Scroggin heirs and legal representatives of Samuel Scroggin dec'd by Henry Bohannon commissioner appointed by the Shelby Circuit Court of the first part and Noel K. Johnson of the second part, Witnesseth That the said circuit court did at the present September Term order and decree that the said commissioner should on behalf of the said parties of the first part convey to the said party of the second part the tract of land mentioned and described in the pleadings and papers filed herein containing four and a half acres of land on Six Mile and particularly described in a bond filed herein executed by the said Samuel Scroggin and bearing date the 27th day of Sept. 1845 It also appearing that the consideration money to eight hundred and eighty four dollars has been fully paid. Now in consideration of the premises and of the order and decree of the Shelby Circuit Court aforesaid the said party of the first part by the commissioner aforesaid does by these presents give grant bargain and sell release convey and confirm unto the said party of the second part all of the said tract of land together with the appurtenances thereon to belonging or in anywise appertaining. To have and to hold the land hereby conveyed with the appurtenances unto the said party of the second part his heirs and assigns forever. In witness whereof the said party of the first part by the commissioner aforesaid have hereunto set their hands and seals the day and date first above written.

Malinda Miles Scroggin was enumerated on the 1860 Shelby County census as a farmer with real estate valued at \$2100 and personal property worth \$1200.⁸⁰

The two-year-old boy, whose name appeared to be something such as Loring, has not been connected with Malinda.

According to her tombstone, Malinda Miles Scroggin died on 26 June 1872. A court order was issued on 16 July 1872 for an appraisal of her estate. The inventory and appraisement was submitted to the Shelby County Court later that year.⁸¹

An inventory and appraisalment of the personal estate of Malinda Scroggins dec'd was this day produced in court by her administrator J. S. Scroggins which was examined and approved of by the court and ordered to be recorded.

A settlement filed 09 March 1874, listing the debits and credits of the estate, included the names of J. S. Scroggin, Harvey Bohannon, James M. Johnson, T. D. Wilson, Ben Vardeman, H. T. Montfort, Ned Flood and William Scroggin.⁸²

Upon the application of J. S. Scroggin Admr of Malinda Scroggin dec'd who was sole deviser for life of Sam'l Scroggin dec'd ...

The balance of the estate was distributed to each of four heirs; Nannie Mullen, Rena Scroggin and Jeptha and Ada Bohannon. This indicates that Irene "Rena" Scroggin (G100) was unmarried in 1874.

Francis Marion Scroggin (G98), who was born between 1830 and 1835, died 28 November 1853.⁸³

Harvey Bohannon who married Cynthia Ann Scroggin (G97) was a son of Henry Bohannon and Philadelphia Gale and a nephew of William Bohannon whose daughter Pamela married Benjamin Scroggin (F45). Harvey Bohannon and Cynthia Ann Scroggin were wed by Abraham Cook on 31 May 1849 in Shelby County with the consent of his father Henry Bohannon and her father Samuel Scroggin (Scroggan). The bond was secured by Abraham Lewis.⁸⁴ Henry Bohannon was a farmer, surveyor, justice and sheriff of Shelby County, Kentucky. He was a trustee of Indian Fork Baptist Church and a secretary and treasurer of Georgetown College, Georgetown, Kentucky. Harvey and Cynthia Scroggin Bohannon had a son Dr. J. G. Bohannon who was born in Shelby County on 09 October 1852, the first of two boys and a girl.⁸⁵ Cynthia (G97) died in 1872 prior to the accounting of her mother's estate in 1874, which showed as heirs, Jeptha (H267) and Ada (H268) Bohannon who must have been Cynthia's children. Her second son Henry Samuel Bohannon (H269) died in 1867.

Cynthia Ann Scroggin (G97) and Henry Samuel Bohannon (H269) are buried in the Christiansburg Cemetery on Fry-Christiansburg Road, 2.7 miles from Bagdad via State Route 12.⁸⁶

A published biography of Dr. Jeptha G. Bohannon (H267) describes the Scroggin and Bohannon families as of Scots ancestry, the Miles family as English, and the Gale family as French. Dr. Bohannon attended Georgetown College and graduated from the University of Louisville School of Medicine in 1874. He moved to Greenville in Muhlenberg County, Kentucky, in 1878, where he married A. M. Haden, daughter of G. W. Haden and Lucy R. Slaughter, on 02 September 1879. They had two sons, George Harvey Bohannon (J192) and Joseph Haden Bohannon (J193).

Harvey Bohannon married (2) Cynthia A. Gale on 30 October 1873.⁸⁷

Elliott Gale Bohannon who married Nancy “Nannie” Scrogin (G99) was born about 1836, a brother of Harvey Bohannon who married Cynthia Ann Scrogin (G97). Elliott Bohannon, age 18, born in Shelby County, and Nancy Scrogin, age 18, born in Shelby County, daughter of Samuel Scrogin, with consent of her mother Malinda Scrogin (Scroggin) and Henry Bohannon, father of the groom, were married on 20 December 1855 in Shelby County by Thomas M. Daniel before witnesses George Radford, S. E. Miles and Isaac Sacry. Harvey Bohannon was bondsman.⁸⁸ Elliott died after 1857 and before 1860, when Nancy was identified as a widow, with a son Lowry Bohannon, aged 2, in the household of her mother. On 03 March 1870 Nancy married (2) Merritt J. Mullen (c1831-c1878), son of John McMullen and Mary McGovern, who were married in Ireland about 1805-1810. Merritt J. Mullen married (1) Frances R. Farnsley, daughter of James J. Farnsley, Jr. and Frances Oldham Prince, on 07 May 1861 in Jefferson County, Kentucky. They had two children, Ida May Mullen (born 1862) and William B. Mullen (born 1863), before Frances died on 16 January 1869 and was buried the following day in Cave Hill Cemetery in Louisville. Merritt J. Mullen died before the 1880 census was taken in Shelby County, Christiansburg District, when Nancy was enumerated as a widow and seamstress, with her son Lowry and sister Irene in residence with her.⁸⁹

John Samuel Scrogin (G101) was residing with his mother and unmarried sister Irene (G100) in Christiansburg Precinct on 02 July 1870:⁹⁰

Alice Mariah Wilson, who married John Samuel Scroggin (G101) in Boone County, Kentucky, on 27 February 1872, was a daughter of Cumberland H. and Angeline Wilson. Cumberland H. Wilson was a son of Thornton J. Wilson and Mariah Kendrick who were married in Bourbon County, Kentucky, on 24 May 1818. Mariah Kendrick Wilson was the sister of Rachel Kendrick who married John Scroggin (E14).⁹¹ Thomas D. Wilson, son of Thornton J. Wilson and Mariah Kendrick who was born in Boone County, Kentucky, on 21 February 1836 and moved to Shelby County in 1861, married Belle Miles (G118), daughter of Abraham Miles and Irene Scroggin (F71), in 1860.⁹² Thomas D. Wilson of Boone County, aged 24, 1st marriage, farmer, born Boone County, father born Virginia, mother born Bourbon County, and Belle Miles of Shelby County, age 18, 1st marriage, born Shelby County, father Abram Miles born Shelby County, mother born Bourbon County, married on 13 December 1860, bondsman S. E. Miles.⁹³

John Samuel Scroggin (G101) and Alice Mariah Wilson moved to Young County, Texas, after the birth of their son Hubert about 1875 and before 1880 when they were tabulated on the census there. and P. Kesler was their first child, John Ezra Kesler (H187), who was born in 1850 and died in 1851. Rachel Ann Miles (G105), daughter of Abram, married Thomas D. Kesler on 25 October 1849 with Robert Montgomery as bondsman.⁹⁸ Rachel Ann Miles (G105) was born on 11 August 1833 and died in February 1910. Thomas Dudley Kesler, who was born on 24 May 1828 in Shelby County and died there on 21 May 1903, was a son of James W. They were married on 13 December 1860 with S. E. Miles as bondsman.¹⁰³

Peter Vardeman who married Mary “Polly” Scrogin (F94) was a son of Thomas Vardeman and Mary “Polly” Wilcoxson who were married in Woodford County, Kentucky, on 29 October 1804. Thomas Vardeman was a son of Peter and Prudence Vardeman. Polly Wilcoxson Vardeman was a sister of Jane Wilcoxson who married William Bohannon and a daughter of Daniel Wilcoxson and Sally Faulconer who were married in Kentucky in October 1780.¹¹³

After the death of Thomas Vardeman, Polly Wilcoxson Vardeman married (2) Samuel Miles, Jr., son of Samuel Miles and Sarah James, on 03 April 1822 in Shelby County with Nathan Underwood as bondsman.¹¹⁴ She was the third wife of Samuel Miles, Jr. who married (1) Eunice Cook, daughter of William Cook and Margaret Jones, on 24 February 1798 in Franklin County, Kentucky,¹¹⁵ and (2) Ann Lewis, daughter of Joseph Lewis and Sarah Beck, on 07 April 1802 in Shelby County, Kentucky.¹¹⁶ Subsequently Polly Miles was guardian of the heirs of Thomas Vardeman; Peter, William and Mary Vardeman, and made guardian’s reports on 16 November 1829 and 16 August 1830, the latter being witnessed by Henry Bohannon, Justice of the Peace for Shelby County.¹¹⁷

Peter Vardeman was born on 01 August 1810, died on 30 August 1877 and is buried in Bagdad Cemetery, Bagdad, Kentucky. Appraisals and sales reports pertaining to his estate, beginning 14 September 1877 and administered by his son Jeremiah P. Vardeman (G123), mention his widow Mary and an unnamed infant child.¹¹⁸ Peter Vardeman and Polly Scrogin (F94) reputedly had 13 children but the names of only 11 are known. The other two were a son born between 1830 and 1835, probably about 1832, who died before 1850, and an infant (minor) living in 1877 who was born after the 1860 census.

His widowed mother Mary "Polly" Wilcoxson Vardeman Miles apparently lived with Peter in 1840:¹¹⁹

Angeline Vardeman (G127), daughter of Peter Vardeman, married John S. Riddle on 13 February 1855 with Jeremiah Vardeman as bondsman.¹²²

Elizabeth F. Vardeman (G125) of Shelby County, daughter of Peter Vardeman, who was surety on the bond, married Benjamin Onan of Shelby County, on 07 July 1859.¹²³ Benjamin Onan was born on 01 January 1835, died on 19 April 1865 and is buried at Indian Fork Baptist Church. Cleopatra Onan, daughter of B. and E. Onan, who was born on 18 September 1862 and died on 23 September 1862, is also buried there.¹²⁴ Since Elizabeth Vardeman Onan is not buried with them, under that name, she probably married another man after Benjamin died.

Sarah Mildred "Sally" Scarce, who married William Vardeman (G126) on 10 November 1864, with G. T. Scarce as security on the bond, was the daughter of James Scarce and Mildred Blades. She was described as of Shelby County, aged 21, 1st marriage, born in Shelby County, daughter of James Scarce, born in Shelby County, mother born in Shelby County. William Vardeman (G126) was described as of Shelby County, aged 22, 1st marriage, farmer, born in Shelby County, father born in Shelby County, mother born in Kentucky.¹²⁵

Benjamin Vardeman (G127) and Anna Brown were married on 18 July 1867 with Arman Brown as bondsman.¹²⁶

One family record states that the wife of Quentin D. Vardeman (G132) was named Mary and that they were the parents of Charity F. Vardeman Rogers (H279), Clara C. Vardeman (H280), Winford Vardeman (H281), Mary E. Vardeman (H282) and Otho Vardeman (H283).

Q. D. Vardeman (Vardiman) owned two lots and L. Vardeman (Vardiman) owned one lot in the village of Consolation in Shelby County in 1882. T. J. Vardeman (Vardiman) lived east of Consolation and north of Stringtown in the hills along North Benson Creek.¹²⁷ Situated between Bagdad and Jacksonville, Consolation was on the Louisville, Cincinnati and Lexington Rail Road line. When the tracks were re-laid in a deep cut near Consolation, the community was bypassed and soon dwindled.

Although the marriage record of William Vardeman states that his father Peter was born in Shelby County, Kentucky, it is probable that he was a native of Woodford County. Thomas Vardeman, father of Peter Vardeman, was a resident of Woodford County in 1820.¹²⁸

William Vardeman, son of Thomas and Mary Wilcoxson Vardeman, was born in 1813 in Kentucky. The name of his first wife has not been determined. He married (2) Mrs. Letha Bohannon Christie, daughter of Henry Bohannon and Philadelphia Gale and widow of Jeffrey B. Christie, son of Henry Christie. Letha Bohannon Christie Vardeman married (3) Richard Day on 22 December 1898 in Shelby County.¹²⁹

Sallie Vardeman, daughter of Thomas Vardeman and Mary Wilcoxson, was born in 1818

and died on 24 March 1888. She married Stephen Martin who was born in 1814 and died on 27 February 1879. They were the parents of Mary Martin, Martha Martin who married (1) Alfred Facker (Fecker) and (2) T. J. Hill, Letha Martin, and William M. Martin, who was born on 09 July 1846 and died on 09 February 1924. William married (1) Nannie Magruder on 03 February 1876 and (2) Mildred Wade on 09 March 1887 in Franklin County, Kentucky. By his first wife, he had Ira Willie Martin and Chester David Martin. By his second wife Mildred Wade (1862-1944), daughter of Obediah Wade and Eusebia Cook, he had Hallie Neville Martin, who was born on 06 March 1889 and married Leonard Christopher Kesler (J104), son of Walter James Kesler (H138) and Myrtle Forrest Scrogins (H69), on 27 February 1919.¹³⁰

Mary "Polly" Vardeman, daughter of Thomas Vardeman and Mary Wilcoxson, married Jackson Yunt (Yount) on 29 June 1837 in Shelby County.¹³¹ She apparently died before 21 September 1865 when Jackson J. Yount married (2) Elizabeth Hammond in Shelby County.¹³²

Thomas Vardeman, who married Mary Wilcoxson, was the son of Peter and Prudence Vardeman who moved to Shelby County before 22 July 1808 when Peter, the elder, made his will naming his wife Prudence, son Thomas, daughters Dorcas Greer, Naomi Marshall, Prudence Marshall and Molly Menefee, granddaughters Patty Menefee, Naomi Nash and Sally Lancaster, and sons-in-law George Marshall and Lewis Marshall.¹³³ Prudence Vardeman married Lewis Marshall in 1789 and Naomi Vardeman married George Marshall in 1796 in Bourbon County, Kentucky. The Baptist congregation that was established in 1787 at Cooper's Run in Bourbon County met at the "schoolhouse at Brother Vardiman's" in its early days. The parents of Rachel Kendrick, wife of John Scrogin (E14), belonged to Cooper's Run Baptist Church.¹³⁴

Peter Vardeman apparently came to Kentucky from Franklin County, Virginia, where his name appears in court records. Thomas Hale was appointed a captain of the Henry County, Virginia, militia in "the room of Peter Vardeman" in 1779.¹³⁵ Franklin County was formed from Henry County, Virginia, in 1786.

Lewis and George Marshall, who married Prudence and Naomi Vardeman, were sons of the Reverend William Marshall (1735-1809) and Mary Ann Pickett, daughter of William Pickett, who were married in 1766. William Marshall, a Baptist minister, and his wife came to Kentucky in 1779, settling first in Lincoln County and then in Henry County.¹³⁶

Joshua Tharp, who married Sarah Jane Scroggin (F72), was a son of John Tharp (born 09 December 1770; died 02 August 1853) and Rebecca Lee. Rebecca Lee Tharp was a daughter of Daniel and Mary Lee. Joshua and Sarah Jane were married by Baptist minister Abraham Cook in Shelby County, Kentucky, on 20 August 1835.¹³⁷ They were residing in Hendricks County, Indiana, by 1845, when their son William Benjamin Tharp was born.¹³⁸ This biographical sketch does not include daughter Mary Ann Tharp who married Richard Henry Pinnell in Vermillion County, Indiana, in 1860.¹³⁹

Joshua Tharp moved to Indiana after 1840 when he still was a resident of Shelby County, Kentucky.¹⁴⁰

ADDENDA

Peter Vardeman of Henry County, Virginia, must have been descended from John Vardeman, who emigrated from Sweden to America with his family, settled in South Carolina in the early 18th century and died there, according to descendants, at the extreme age of 125 years. He was a Lutheran in Sweden and joined the Episcopalian Church in South Carolina. His son John Vardeman, Jr., who was seven years old at the time the family emigrated, married Elizabeth Morgan, a native of Wales, and moved to Bedford County, Virginia, on the east slope of the Blue Ridge Mountains, not far from the Peaks of Otter. There he and his wife affiliated with the Baptist Church. They had twelve children, of which the four eldest sons were William, John, Amaziah and Morgan Vardeman. About 1767, John Vardeman, Jr. migrated with his young family to the settlements on New River, where his last child, son Jeremiah Vardeman, was born on 08 July 1775, in what is now Wythe County, Virginia, about twelve miles above Fort Chiswell. In 1777 he went further west to the Clinch River in southwestern Virginia. When Indian trouble arose, the family moved into the nearby fort of Shadrach White on the Maiden Spring Fork of the Clinch in what is now Russell County. Others there included the noted hunters and explorers, James, Henry and Richard Skaggs. In autumn, 1779, the Vardemans went to Kentucky and settled near Crab Orchard in what became Lincoln County. Son William, who was the first to settle in Kentucky, fought at Point Pleasant on 10 October 1774. Later he went to the Natchez country. Sons John (III) and Amaziah were in George Rogers Clark's campaign against the Shawnee in 1782. Sons Amaziah and Morgan served under Colonel William Whitley on scouting expeditions and in the campaign to Nick-o-jack (sic) in September 1794. Son Jeremiah also fought against the Indians. John Vardeman, Jr. moved to Missouri where he died about 1827 at the age of 109. (Photocopy of undated, anonymous typescript from Valerie Hurd, POB 1066, Sundance, WY 82729-1066.) William Whitley led a group of Kentuckians, who joined a force of Tennesseans at Nashville, against the southern Indians who had been harassing the settlements in Lincoln County. The expedition became known as the Nickajack campaign from the name of the major Indian town, which was destroyed. (*Collins' History of Kentucky*.) If John Vardeman, Jr. was 109 when he died about 1827 and 7 when his family came to America, he must have been born about 1718 and emigrated about 1725. However, with his twelfth child being born in 1775, it could be estimated that he was married about 1750, which suggests that he may have been born later than 1718.

Much of the above Vardeman history came from Morgan Vardeman, son of John Vardeman and Elizabeth Morgan, during an interview with Lyman Draper [Data of Sharon Primeau primeau@pcok.com<, transcript, Microfilm I2 C, *Daniel Boone Papers, Draper Manuscripts*, Wisconsin State Library, Madison.]

Jeremiah Vardeman (youngest son of John and Elizabeth) was born in what is now Wythe County, then old Fincastle on the New River, about 12 miles above Ft. Clinwell (?) in the spring of 1775 (1775 crossed out). His father was John Vardeman who came to Kentucky to mark the road, in company with him (appears to this reader to be Drake (Dokes?), a brother and Boone and another illegible name in the spring of 74 (this crossed out and 75 inserted). He (John) died at his sons home in Missouri about 1827 (his son Jeremiah and others of the family lived in Mo. in 1827), aged

about 109 years old, a native of Sweden and at 7 years old, his father and family emigrated to America and settled in South Carolina and there the old man (John Vardeman, Sr.) died at the advanced age of 125 years, a man of piety of the established church. There Vardeman (John, Jr.) married young Elizabeth Morgan, a native of Wales in South Carolina and soon after settled in Bedford Co., Va. and there united with the Baptists and ever after continued a religious profession. About the year 1767 moved to New River, in 77 removed to Clinch and there forted at Shadrach Whites, in the neighborhood of Maiden Spring fork of Clinch, there Skeggs, James and Henry and Richard, all noted hunters all forted at this same time (with families) at Whites.

Jeremiah Vardeman died in Ralls County, Missouri, between 01 January 1842, when he made his will, and 06 June 1842, when it was proved in court: [E-mail data of Sharon Primeau <primeau@pcok.com 06 May 1997.]

Higgins, two of the subscribing witnesses thereto, which is duly admitted to record in the office of the Clerk of said courtm a true copy of which is hereunto annexed and Lucy Vardeman, executrix named in said will, having refused to qualify, therefore I, John Ralls Clerk of the said Court, by virtue of the authority vested in me by law, im vacation of the said Court do hereby give and grant unto Jeremiah B. Vardeman and William H. Vardeman the executors named in the said will, full power and authority to administer all and singular the lands and tenements, goods, chattles, moneys, credits and effects of the estate of the said Jeremiah Vardeman, deceased, agreeably to his last will and testament and the law in such cases made and provided, the said executors having given bond with security and complied with the othere requisitions of the law, wheresoever the same may be found in the State of Missouri, to collect and in a legal manner to require and receive all manner of debts due

I give and bequeath to my dear and loving wife Lucy Vardeman all my real and personal estate with exception of, to her three children, Thomas B. Vardeman, Caroline Vardeman and Emily Jane Vardeman, I give and bequeath to my two sons, Jeremiah Vardeman and William Vardeman one hundred and twenty acres, three hundred and twenty acres, one hundred and forty acres, amounting to 580 acres of land. I also give and bequeath to my son Jeremiah, my two slaves Henry and Jack, I also give Jeremiah to be taken when he married, two cows. I also give and bequeath to my son William, three slaves, Anthony, Queen and Ned, I also give to William two cows when he marries, I give thes bequests because they have been dutiful sons and stayed with and assisted me in my decline of life, I give and bequeath to my daughter, Didama Fuller and her two sons, James Matson and Richard Matson, one dollar each, I do this because I gave the same Diadama at her marriage as much as I intended to

give her and because the said James and Richard have more property than I am able to give each of my children. I give to my four grand children, Marthy Singleton, John Porter, Lutitia Porter and Jeremiah Porter, the children of my daughter Elizabeth Porter, deceased, each one dollar. I gave to Elizabeth what I intended when she married. I give to four grand children, James Culbertson, Ann Eliza Culbertson, Jeremiah Culbertson and William Culbertson children of my dau. Mary F. Culbertson, one dollar each. Gave to Mary her portion when married and children seem to have the prospect of living as well as my own children. I give and bequeath to my dau. Sarah M. Griffin the possession of a tract of land lying in Audrain County containing 320 acres to possess during her life, I give land in trust to her children the children of said Sarah Morgan Griffin, I am convinced if I were to give my dau. Sarah any property whatever it would be lost to her and the estate forever, because the involved situation of James Griffin her husband, would cause any property that might fall into his or her hands to be taken immediately to help satisfy his debts, therefore I permit them abarely (sic) to enjoy the possession of said land during her lifetime. I set my hand first day of January 1842, Jeremiah Vardeman

Lucy apparently was the second wife of Jeremiah Vardeman. Elizabeth James, born about 1780 and died in 1823 in Pulaski County, Kentucky, married Jeremiah Vardeman, a Baptist preacher in Pulaski County near the towns of Somerset and Shopville, who was born about 1775. Elizabeth had two brothers, Daniel Fields James and Joseph Martin James who also were Baptist ministers. Joseph Martin James had a son Joseph McAlister James who married one of his first cousins, Elizabeth Vardeman James. [E-mail query of Eric James <ericjames@re4sale.com>01 May 1997.]

A Vardeman family reunion was held in Marshall, Missouri, on 27 August 1939 by the descendants of Thomas Vardeman (G124) and William Vardeman (G126), at which time Bonnie Vardeman Conaway, daughter of Thomas, prepared *A Short Biographical Sketch of the Lives of Thomas and William Vardeman*: (Photocopy of typescript from Valerie Hurd, POB 1066, Sundance, WY 82729-1066.)

It is meet that we, who gather here today, render this tribute of praise and remembrance to those who have gone before. We are the children, grandchildren, great-grandchildren, nieces, and nephews of two brothers--Thomas and William Vardeman.

We meet today partly to honor Jeremiah Vardeman, fourth son of Thomas Vardeman, who with his wife has come from Portland, Oregon, to visit us--partly because some of us have passed our three score years and ten, and time may be short when we can meet with each other.

My father, Thomas Vardeman was born in Shelby County, Kentucky, October 2, 1838, and four years later on the same day of the same month my uncle William was born. They were children of a large family, reared in fear and admonition of

the Lord. They became Baptists ministers as did also Abraham, a younger brother of theirs.

They grew to manhood in the State of Kentucky, and both saw service as Union soldiers in the Civil War. My father enlisted October 14, 1861--was discharged because of a bullet wound, December 31, 1864, and then rendered eleven additional months of hospital service. I do not know in what year of the war my uncle enlisted. He served more than a year.

They were married while comparatively young men. Uncle Will married Sallie Scarce (sic), who became dear Aunt Sallie and the mother of four girls. A few years later, December 8, 1866, father married Cornelia Fenwick Gaines, who became our precious mother. There they farmed, raising various grains, livestock, and tobacco; mostly tobacco.

Yielding to the general unrest and spirit of progress, Uncle Will moved his family to Indiana about the year 1876. He farmed there for a while, and in the year 1878 came to Missouri, bought a small farm on the Marshall-Miami road and sent for his wife and four girls the same fall. They came on the river by boat to Miami where Uncle Will met them in a farm wagon. They stayed over night at a crude hotel in Miami experiencing great discomfort, and the next day proceeded on their journey by wagon to their new home.

About four years later on the fourteenth day of March, 1882, my father with my mother, six brothers and one sister, his family at that time, arrived in Marshall. Uncle Will met them in a farm wagon, drawn by four mules, and they drove out on what is now North Odell Avenue over a stumpy road through muddy Salt Fork bottoms where they stuck once, to be helped out by Messrs. Bob and Henry Irvine--on to my uncle's farm, north and west of Marshall. He had made a change of homes since coming to Missouri.

They found my aunt and cousins waiting for them in semi-darkness; their only light, a lantern and tallow candles. They had broken their lamp flues that morning in the excitement of getting ready for their Uncle Tom, Aunt Nellie, and the children.

My uncle and father were almost pioneers. The Indians were gone when they came to Missouri, but flocks of wild turkeys were in the woods--and there were plenty of weeds--hazel brush and uncleared land. Hazel nuts, hickory nuts, and acorns were plentiful; also wild grapes, wild plums, blackberries, strawberries, and all kinds of wild game.

With the exception of one year my father and family lived on various farms north of Marshall until the year 1908. We had increased to eleven children of which I was the first "Puke." We younger members were all girls, so that we were then as we are today, six brothers and five sisters.

In that year 1908, my father bought a small farm near Nelson, Missouri, and moved my mother and unmarried children. He made his home there until the fall of 1919, when he sold the farm and bought property in Marshall, continuing to live there the remainder of his life.

Uncle Will lived north of Marshall until the year 1920, when he too made Marshall his home, living there until his death.

The two brothers and their families were, for many years, the only relatives in Missouri, and they were always friendly and had great regard for each other. One cousin says, "There was no greater pleasure in our childhood than going to see the cousins and having them come to visit us."

I feel sure all eleven of us can reiterate that statement. Going to Uncle Will's when a child, eating Aunt Nellie's salt rising bread, yellow butter, and jam, watching her rock serenely and receiving notice from the cousins was my realization of earthly heaven. My father and my uncle lived to see many marvels of science. They saw the laying of almost the first, perhaps the first railroad in Kentucky and an early one here.

One of the cousins remarked that the roar of the early trains filled her childish heart with more terror than thoughts of the Devil. Electric lighting, the auto, the airplanes were in use before their deaths. The radio with earphones was just coming in at the time of their passing. None of these things moved their faith in God--rather heightened their faith in him. Did not God make men in his own image?

My father did itinerant missionary work, but held no regular pastorate in Missouri. A cousin says, "The brothers loved the Bible. Their eyes shone with joy as they discussed the great truths it contains, and in passing they pillowed their heads on its promises."

Uncle Will was a great worker for the Lord, serving four rural churches of Saline County for years. Two of them, Salem and Pin Oak, were organized through his efforts, and the influence of his life and work will live forever. It was my privilege to attend a service at one of his churches a few years ago, and I could seem to feel his spirit present.

My father died in the fall of 1923, at the age of 85 and was laid to rest beside my mother who preceded him two years.

Uncle Will died two years later, October 1925, at the age of 83 years. Pointing upward his last words were "Mommie" (his name for my aunt), "Heaven."

Aunt Sallie lived until October 1928 when she, too, passed on and was laid beside my uncle in Ridge Park. The brothers and their wives lie close together in death.

Of my father's immediate family all eleven children are living. Of my uncle's immediate family three daughters yet live, one widowed and two unmarried. His oldest daughter Mrs. Henry Harvey died last fall. She left a fine family of six children.

Among the brothers' numerous descendants are to be found; a doctor, a preacher, a school teacher, a policeman, and many worthy followers of various occupations.

Yes, their work on earth is over,
Only we who yet remain,
Hold the banner they have left us,
May we keep it free from stain.

Side by side in Ridge Park lying
Side by side and head to head
We can hear our Savior saying,
"Only sleeping, they're not dead."

When, on Resurrection morning
They, the trumpet call obey,
There will be a glad reunion
Through God's one unending day.

Although the 1850 census enumeration of Peter and Mary Scrogin Vardeman lists son Thomas as T. F. Vardeman, his obituary in the *Democrat-News* of Marshall, Missouri, gives his name as the Reverend John Thomas Vardeman, the Ridge Park Cemetery records give his name as John T. Vardeman and the 1900 census for Saline County, Missouri, lists him as John Vardeman. (Data of Valerie Hurd.)

Although one family record shows that the wife of Quentin D. Vardeman (G132), was named Mary and that they had a daughter named Charity F. Rogers, the tombstones of Bagdad Cemetery indicate that Q. D. was married to Charity: (*Bagdad Cemetery, Shelby County, Kentucky*, Ramona S. Slattery, Cemetery Projects Chairman, The Kentucky Genealogical Society, Frankfort, 1996.)

The last two markers must pertain to unmarried daughters of Q. D. and Charity, who have otherwise been identified as Winford Vardeman (H281) and Mary E. Vardeman (H282). Elizabeth Vardeman died on 28 February 1920 in Jefferson County, Kentucky, where she resided (Volume 021, Certificate 10034, Death Volume 20, Kentucky Vital Records Index Internet web page.) Winfred Vardeman died on 30 January 1955 in Shelby County. (Volume 007, Certificate 03067, Death Volume 55, Kentucky Vital Records Index Internet web page.)

Charity F. Rogers (Rodgers) died on 03 April 1916 in Shelby County. (Volume 19, Certificate 09022, Death Volume 16, Kentucky Vital Records Index Internet web page.) This indicates that Charity was married for a second time after Q. D. died.

The middle name of Mary W. Scrogin Vardeman may have been Wilcoxson.
